- Incomplete applications will not be processed and will be returned to the contractor or homeowner.
- SCI REMC issues rebates in the form of checks, not energy bill credits. Allow 3-4 weeks for processing.

Deadline to apply for 2019 Rebate Program is Dec. 20, 2019. The cooperative reserves the right to approve, deny or select the appropriate rebate. The co-op also reserves the right to inspect and verify installation of equipment receiving a rebate.
