DUSK-TO-DAWN SECURITY LIGHT RATE RATE SCHEDULE - SL EFFECTIVE FEBRUARY 1, 2024

Availability

Available to any consumer of the Corporation providing 120-volt service exists ahead of the meter loop that can be contacted for the purpose of installing dusk-to-dawn security lighting. Mercury vapor dusk-to-dawn security lighting available only to consumers with already existing mercury vapor lighting service.

Type of Service

Dusk-to-dawn lighting service using photoelectric controlled equipment, including any and all equipment necessary to make the complete installation on a consumer's meter pole or service drop lift pole, shall be considered to be a part of this rate.

Any installation requiring additional material to serve dusk-to-dawn security lighting beyond the point of power contact which requires additional poles and wire will be billed to the consumer.

Monthly Billing

All dusk-to-dawn security lighting charges shall be included on the consumer's monthly billing and shall be paid at the same time and under the same terms and conditions as the consumer's regular monthly billing. The above rate is net, the gross rate being 5% higher on the current net monthly bill. In the event the current monthly bill is not paid within seventeen (17) days of the bill date, the gross rate shall apply. When the seventeenth day falls on Sunday or any other legal holiday, the first business day thereafter shall be added to the seventeen-day period. If a delinquent balance exists, all payments will be first applied to such delinquent balance.

Maintenance of Security Lighting

The Corporation shall maintain service to all dusk-to-dawn security lighting subject to this rate schedule. All maintenance will normally be done only during regular working hours. All poles, equipment, fixtures, and wire sold to the consumer to provide security lighting beyond the point of power contact is the property and responsibility of the consumer.

Conversion Charge

.Any consumer wishing to change their dusk-to-dawn security light to one with a different wattage shall pay a conversion charge prior to the conversion. The conversion charge shall be the charge as stated in Appendix B.

Interpretation of Schedule

The interpretation of or the application by the Corporation or by any consumer of all rates, rules, and regulations included in this rate schedule shall be subject to review by the Board of Directors of the Corporation, consistent with its service rules and regulations or policies, except as otherwise provided by law.

Miscellaneous Nonrecurring Charges

Consumers served under this rate schedule shall be subject to the miscellaneous nonrecurring charges as stated in Appendix B, which may be charged to the consumer as applicable.

Rate Schedule Modifications

All rate schedules and charges, as well as the Corporation's service rules and regulations or policies, may be amended or modified, in whole or in part, at any time as deemed appropriate by the Corporation's Board of Directors.
