

**SOUTH CENTRAL INDIANA RURAL ELECTRIC MEMBERSHIP CORPORATION**

**STREET LIGHTING SERVICE RATE  
RATE SCHEDULE STL-1  
EFFECTIVE FEBRUARY 1, 2024**

**Availability**

Available to any municipal, government agency, commercial account, or homeowners association for street lighting in and around public parking areas, public roads, and vehicle access roads. Applicant must be adjacent to an existing electric power line of the Corporation that is adequate and suitable for supplying the lighting service.

**Type of Service**

Dusk-to-dawn lighting service using photoelectric controlled equipment. All equipment, including fixtures, supporting structures and electrical apparatus shall be owned, installed, and maintained by the Corporation. Maintenance of the complete assembly and the cost of its electrical operation are included in this service. Any additional investment required for the extension of secondary service lines or the installation of a transformer, will be billed to the consumer.

**Monthly Rate**

Rates for street lighting service shall be on a per-lamp basis. All fixtures shall be connected directly to the Corporation's secondary service line and shall be lighted and extinguished by a photoelectric control. The hours of operation are estimated to be from 15 minutes after sunset to 15 minutes before sunrise daily for approximately 4,100 hours per year.

### **Monthly Billing and Terms of Payment**

Billing for area lighting service as supplied under this schedule will be submitted by the Corporation to the consumer monthly. The above rate is net, the gross rate being 5% higher on the current net monthly bill. In the event the current monthly bill is not paid within seventeen (17) days of the bill date, the gross rate shall apply. When the seventeenth day falls on Sunday or any other legal holiday, the first business day thereafter shall be added to the seventeen-day period. If a delinquent balance exists, all payments will be first applied to such delinquent balance.

### **Maintenance of Street Lighting**

The Corporation shall maintain service to all street lighting subject to this rate schedule. All maintenance will normally be done only during regular working hours. All poles, equipment, fixtures, and wire sold to the consumer to provide security lighting beyond the point of power contact is the property and responsibility of the consumers.

### **Termination of Service**

The customer may request termination of service at their option and the Corporation will remove the fixture within a reasonable period of time. The Corporation may terminate service 30 days after written notice to the consumer due to improper maintenance of the lighting equipment by the consumer.

### **Interpretation of Schedule**

The interpretation of or the application by the Corporation or by any consumer of all rates, rules, and regulations included in this rate schedule shall be subject to review by the Board of Directors of the Corporation, consistent with its service rules and regulations or policies, except as otherwise provided by law.

### **Miscellaneous Nonrecurring Charges**

Consumers served under this rate schedule shall be subject to the miscellaneous nonrecurring charges as stated in Appendix B, which may be charged to the consumer as applicable.

### **Rate Schedule Modifications**

All rate schedules and charges, as well as the Corporation's service rules and regulations or policies, may be amended or modified, in whole or in part, at any time as deemed appropriate by the Corporation's Board of Directors.
